Following Agents Notice 341 dated 25<sup>th</sup> September 2014, please see below the changes in excess baggage rates effective 1<sup>st</sup> October 2014 for passengers travelling \*Europe – Africa - Europe. **The changes are highlighted in blue**.

# Please see below amended excess baggage rates

PIECE / BAG	ROUTE	CHARGES IN EUR
1 <sup>st</sup> Piece	Europe-Africa-Europe	€200.00
2 <sup>nd</sup> Piece	Europe-Africa-Europe	€200.00
3 <sup>rd</sup> Piece and more	Europe-Africa-Europe	€300.00
Any piece within the free baggage allowance exceeding the permitted weight (23kgs) but under 32kgs – HEAVY BAG	Europe-Africa-Europe	€100.00
*Special baggage	Europe-Africa-Europe	€175.00
<b>Approved</b> Bag exceeding 32kgs and/or more than 158cms	Europe-Africa-Europe	€350.00



**EUR** amount should be converted to GBP at the current rate of exchange

\*Special baggage would be sporting equipment (Bicycle, Scuba Tank etc)

#### Free Baggage Allowance in Premier World

- 2 PC maximum weight 32kgs per piece / size (L, H, W) 158 cm per piece
- 2 PC cabin baggage (max L55x W25 x H35 cm each)-weighing no more than 12kgs + 1 Accessory -please see the list below.

## Free Baggage Allowance in Economy Class

- 2 PC -maximum weight 23kgs per piece / size (L, H, W) 158 cm per piece
- 1 PC cabin baggage (max L55x W25 x H35 cm each)-weighing no more than 12kgs + 1 Accessory please see the list below.
- INF not occupying a seat 1 PC of cabin baggage weighing no more than 12kgs and maximum dimensions L55 x W25 x H35cm

\*\*Children and Infant Occupying a Seat (Child fare) will be eligible to the above.

## Accessories

- 1. Handbag
- 2. Briefcase
- 3. Camera Bag
- 4. Laptop
- 5. Or any other item smaller or of identical size

**Stopovers**: Long haul Baggage Allowance will apply on itineraries with stopovers on either outbound or inbound. This includes flights on PW.

## **Requirement & Information**

- It is required that all checked baggage shall have a name label containing passengers details e.g. physical address / telephone number / email address
- Infants and Children less than 12 years old will be allowed to take 1 collapsible pushchair / stroller plus 1 car seat.
